How to Apply for Rebates

1. Complete rebate application for each installation address. Electronic rebate forms can be found at CenterPointEnergy.com/Foodservice
2. Rebate applications must include a dated copy of the paid, itemized invoice(s). Invoices must include brand, complete model number, purchaser's name and installation address.
3. Dealers/Trade Ally partners participating in the incentive program are required to include your six digit ID number. If you do not know your ID number, please contact CenterPoint Energy at 612-321-5470 or 800-234-5800 ext. 5470.
4. If you have questions, please contact your CenterPoint Energy account manager or one of our energy efficiency experts to discuss and/or complete the rebate application form.
